#### **Answer:**

As set out in the Aviation Green Paper, the Australian Government is considering the recommendations from the Review of the Sydney Airport Demand Management Scheme, with a particular eye to modernising the slot allocation framework and strengthening compliance measures to ensure that slots are not being misused by airlines. The Government has indicated it will have more announcements to make about these reforms in due course.
