# Answer:

Responses to this question are prefaced noting that the Australian Transport Safety Bureau (ATSB) does not have a Board. The ATSB has a Commission which does not perform the same functions as a Board.

Ms Catherine Scott's appointment expired on 7 September 2023 after a term of three years. Before the expiry date the ATSB Chief Commissioner appointed a recruitment selection panel consisting of internal and external panel members to identify suitable candidates. This process included the incumbent as an applicant. The selection panel interviewed the shortlisted candidates, and the Chief Commissioner submitted the names of proposed nominees to the Minister. The Department of Infrastructure, Transport, Regional Development, Communications and the Arts separately provided advice to the Minister. The Minister made a decision and, as per the Cabinet Handbook instructions, sought endorsement for the new appointment from the Prime Minister. With the Australian Government's endorsement, the Minister signed the Instrument of Appointment to appoint

a new member to the ATSB Commission. There were no issues regarding meeting quorum at any time.
