**Answer:**

The Freedom of Information request sought records that did not exist and information was collated and provided as an administrative release. That information contained errors as there were duplicate records resulting in higher totals for Class 1 medical certificates.

The numbers provided in Committee Question Numbers 273 (SQ23-003974) and 191 (SQ23-003788) from the 2023-24 Budget Estimates Hearing outline the number of medical certificates issued over the past five years that have included a restriction requiring there to be a second pilot only. This is the sum of Class 1 and Class 2 certificates from the above table, and do not include Class 3.
