2. What action is being taken to address the high level of ComCare claims?
3. What is the total cost to AirServices Australia of the ComCare claims?
4. How many working days have been lost due to ComCare incidents in AirServices Australia?
5. What type of injuries are leading to ComCare claims in AirServices Australia?

**Answer:**

1. Airservices provides quarterly reports to the minister on its performance which includes information relating to Comcare claims.
2. Please refer to Committee Question Number 58 (SQ23-005164) from the 2023-24 Supplementary Budget Estimates hearing for an outline of actions taken to reduce compensation claims through preventive measures.
3. The cost to Airservices for the 73 claims in FY 2022-23 was \$1,852,851.
4. 2,549 working days were lost as a result of the 73 claims in FY2022-23.
5. Provision of aviation rescue and firefighting services, and the associated physical preparation and activity, is a leading factor for Comcare claims at Airservices.

Type of injury claims referred to Comcare in 2022-23 financial year are in the following table:
