**Answer:**

An annual breakdown of the Civil Aviation Safety Authority (CASA) workforce by aviation technical classification for the period 2010-2023 is shown in Table 1 below. Organisational alignment to move administration functions out of the technical division has occurred, which has resulted in fewer total staff numbers, but maintains the functional and technical deliverables.
