Answer:

Effective from 20 May 2024, members were appointed to reinstate the Compliance Committee for Sydney Airport.

The last appointments to the Compliance Committee expired in 2020. The Department of Infrastructure, Transport, Regional Development, Communications and the Arts has not located any records indicating that the department advised any minister that a decision had been taken that the membership of the Compliance Committee would not be reappointed or replaced.

As set out in the Aviation Green Paper, the Australian Government undertook further targeted consultation last year on potential changes to the Sydney Airport demand management framework, with a particular eye to modernising the slot allocation framework

and strengthening compliance measures to ensure that slots are not being misused by airlines.

On 21 February 2024, the government announced a major package of reforms to the Sydney Airport demand management framework aimed at boosting efficiency, competition and consumers' outcomes while maintaining community protections.
