As described in PQoN 3912, the communication of eligible premises is an ongoing series of updates that occur as the design and construction work is progressively completed around Australia. NBN Co will have an exact number of premises that will be made Ready To Order (RTO) around 10 weeks before each suburb is released. As this program is due to begin in March 2022, NBN Co can commit to providing the specific RTO numbers for each suburb within the first tranche, on notice, after the expected February Additional Estimates hearing.

On high-level analysis, around 10,000 premises have had the local construction complete, with this number expected to rise up to 50,000 by program launch in March 2022. NBN Co are currently conducting the Business Readiness Testing(BRT) in conjunction with a small number of internet retailers to prepare the industry for this program and ensure a smooth launch for the wider community in March 2022. This
