6. Suspension of Standing Orders.—Mr. Barton moved, That the Standing Orders be suspended in order to enable him to make a motion, without notice, in reference to the South African War and Australian aid to the Empire.

Debate ensued.

Question—put and resolved in the affirmative.

- 7. South African War and Australian Aid to the Empire.—Mr. Barton moved accordingly—
  - (1) That this House takes its first opportunity, in view of the despatch of a Federal Contingent to South Africa, to express its indignation at the baseless charges made abroad against the honour of the people and the humanity and the valour of the soldiers of the Empire.
  - (2) That this House affirms the readiness of Australia to give all requisite aid to the Mother Country, in order to bring the present war to an end.

Debate ensued.

And the Motion having by request been divided—

Question—(1) That this House takes its first opportunity, in view of the despatch of a Federal Contingent to South Africa, to express its indignation at the baseless charges made abroad against the honour of the people and the humanity and the valour of the soldiers of the Empire—put and resolved in the affirmative.

Question—(2) That this House affirms the readiness of Australia to give all requisite aid to the Mother Country, in order to bring the present war to an end—put.
