No. 7.—Judiciary Bill—Second recommittal—Clause 4—

4. The qualification of a Justice of the High Court shall be as follows:—He must be either a Judge of the Supreme Court of a State, or a practising barrister or solicitor of the High Court or of the Supreme Court of a State of not less than five years' standing.
