- 1. The House met, at eleven o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir Littleton Groom) took the Chair, and read Prayers.
- 2. PETITION.—Mr. Jackson presented a Petition from 10,429 electors of the State of Tasmania, stating that Federation generally, the Commonwealth Arbitration laws, the irregular interstate shipping service, and the Navigation Act, are all adversely affecting the people of the State, and praying for relief from their disabilities. Petition received and read.

Debate resumed on the motion of Mr. Pratten (Minister for Trade and Customs), viz. :--That notwithstanding anything contained in the *Customs Tariff* 1921-1924, from and after a time and date to be proclaimed, the importation into Australia, direct from the Territory of Papua or the Territory of New Guinea, of such of the goods specified in the Schedule to this resolution as were produced or manufactured in the Territory from which they are imported, shall be free of duty.

Question-put and passed.-Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Clauses 1 to 3 agreed to.

Schedule agreed to.

Title agreed to.

Bill to be reported without amendment.

The House resumed ; Mr. Bayley reported accordingly.

On the motion of Mr. Pratten, the House adopted the Report, and, by leave, the Bill was read a third time.
