WEDNESDAY, 24TH MARCH, 1926.

- The House met, at eleven o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir Littleton Groom) took the Chair, and read Prayers.
- 2. ADJOURNMENT—MOTION FOR PURPOSE OF DISCUSSION.—Mr. Charlton (Leader of the Opposition) rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The necessity for the appointment of local Boards to expedite the settlement of industrial disputes in the Coal Mining Industry".

Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly—

Mr. Charlton moved, That the House do now adjourn.

Debate ensued

Mr. Hughes, addressing the House, and not having concluded his speech at the termination of the time allowed by Standing Order No. 39—

Suspension of Standing Orders.—Mr. Charlton moved, That the Standing Orders be suspended to enable the honorable Member to continue his speech.

Question—put and passed, with the concurrence of an absolute majority of the Members of the House.

Mr. Hughes continued and concluded his speech.

Debate continued.
