MONDAY, 14TH JUNE, 1926.

- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir Littleton Groom) took the Chair, and read Prayers.
- 2. ALTERATION OF DAY OF NEXT MEETING.—Mr. Bruce (Prime Minister) moved, That the House, at its rising, adjourn until to-morrow at three o'clock p.m. Question—put and passed.
- 3. MESSAGE FROM THE GOVERNOR-GENERAL.-ASSENT TO BILL.-The following Message from His Excellency the Governor-General was received, and the same was read by Mr. Speaker :---

A Bill intituled "Northern Territory (Administration) Act 1926," as finally passed by the Senate and the House of Representatives of the Commonwealth, having been presented to the Governor-General for the Royal Assent, His Excellency has, in the name and on behalf of His Majesty, assented to the said Act.
