FRIDAY, 18TH JUNE, 1926.

- 1. The House met, at eleven o'clock a.m.; pursuant to adjournment.— Mr. Speaker (the Honorable Sir Littleton Groom) took the Chair, and read Prayers.
- 2. CONCILIATION AND ARBITRATION BILL (1926).—The Order of the Day having been read for the consideration in Committee of the whole House of Message No. 17 from His Excellency the Governor-General's Deputy.—

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Mr. Latham (Attorney-General) moved, That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the Commonwealth Conciliation and Arbitration Act 1904-1921.

Question--put and passed. Resolution to be reported.

The House resumed; Mr. Bayley reported accordingly.

The said Resolution was read, and, on the motion of Mr. Latham, by leave, was adopted by the House.

3. CONCILIATION AND ARBITRATION BILL (1926).—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House—Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Clause 3

On the motion of Mr. Latham (Attorney-General), the following amendment was made:—
Page 1, lines 12-13, omit", in relation to any question of legislative power,".

Clause, as amended, agreed to.

Clauses 4 and 5 agreed to.

Clause 6 debated.

Mr. West moved, as an amendment, That the words "and of each other Judge" (page 2, lines 21-22) be omitted.

Debate continued.

Amendment negatived.

Mr. Duncan-Hughes moved, as an amendment, That after the word "entitled" (page 2, line 36) the words "subject to the next following sub-section" be inserted.

Debate ensued

Progress to be reported, and leave asked to sit again.

"(2A.) Where a Judge has, prior to his appointment, served in any other judicial office under the Commonwealth, pension shall not be payable to him except in pursuance of this Act, but the term of his prior service shall, for the purposes of this section, be added to, and be deemed to be part of, his service as a Judge."

Clause, as amended, agreed to.

Clause 7 omitted.

Clause 8-

On the motion of Mr. Scullin, the following amendment was made, after debate :-

Page 3, line 19, at end of sub-section (1.) of proposed new section 18B, add the words ", in relation to either of those questions".

Mr. Scullin moved, as a further amendment, That the words "person, or" (lines 23-4) be omitted. Debate ensued.

9B. Section forty A of the Principal Act is amended by adding at the end thereof the following paragraph:-

(c) assign to the Board of Reference any matter affecting the harmonious relationship of the parties to any order or award of the Court ".

Question—That the new clause be added to the Bill—put and negatived. Mr. Scullin moved, That the following new clause be added to the Bill :-

9c. The Principal Act is amended by inserting after section twenty-two:-

"(3.) Upon a registered organization lodging a claim as to any matter upon which the Court is competent to deal, the Court shall cause such matter to be published in the Gazette which shall be deemed to be sufficient notice to the respondents involved in the matter lodged in Court, and the Court will in accordance with any further publication in the Gazette fixing a date for the hearing of the matter so lodged thereupon proceed to hear such matter.".

Debate ensued.

Question—That the new clause be added to the Bill—put.
