- 3. MESSAGE FROM THE DEPUTY OF THE GOVERNOR-GENERAL.-FEDERAL AID ROADS BILL.-The following Message from His Excellency the Governor-General's Deputy was presented, and the same was read by Mr. Speaker :--

#### Deputy of the Governor-General.

#### Message No. 44.

In accordance with the requirements of section 56 of the Constitution of the Commonwealth of Australia, the Deputy of the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to authorize the Execution by the Commonwealth of Agreements between the Commonwealth and the States in relation to the Construction and Reconstruction of Federal Aid Roads, and to make provision for the carrying out thereof.

Melbourne, 7th July, 1926.

Ordered-That the foregoing Message be taken into consideration in Committee of the whole House, forthwith.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

### (In the Committee.)

Mr. Hill (Minister for Works and Railways) moved, That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to authorize the Execution by the Commonwealth of Agreements between the Commonwealth and the States in relation to the Construction and Reconstruction of Federal Aid Roads, and to make provision for the carrying out thereof.

Question-put and passed.

Resolution to be reported.

Question-put and passed.-Bill read a first time.

Mr. Hill moved, That the Bill be now read a second time.

Mr. Charlton moved, That the debate be now adjourned.

Question-That the debate be now adjourned-put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for the next sitting.

Mr. Charlton moved, as an amendment, That the following words be added to the motion-"and that, in the opinion of this House, the Australian delegates should strenuously oppose any attempt to include in the Agenda of the Economic Conference questions of domestic concern". Debate continued.

Mr. Marks moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed. . Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

5. ADJOURNMENT.-Mr. Latham (Attorney-General) moved, That the House do now adjourn. Debate ensued.

Question-put and passed.
