4. INDUSTRIAL DISTURBANCE IN WATERSIDE INDUSTRY—MAINTENANCE OF LAW AND ORDER.—Mr. Bruce (Prime Minister) moved, That in view of the great loss, unemployment and general distress which will inevitably result from the continuance of the serious industrial disturbance in the waterside industry, this House affirms its support of the Government in taking any action the Government thinks necessary, in co-operation with the Governments of the States so far as possible, to maintain law and order and to ensure the continuance of services essential to the well-being of the Commonwealth.
