- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir Littleton Groom) took the Chair, and read Prayers.
- 2. MINISTERIAL STATEMENT-LAW GOVERNING INFRINGEMENT OF COPYRIGHT BY LESSEES OF PUBLIC HALLS .- Mr. Latham (Attorney-General), by leave, made a Ministerial Statement with reference to the liability of the lessees of public halls for infringement of copyright by the illegal performance of copyright compositions in those halls.
- 3. CONCILIATION AND ARBITRATION BILL (No. 2) (1927).—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-Debate resumed.
  - Mr. Makin, Mr. Bruce (Prime Minister), Mr. Charlton, and Mr. Roland Green, in turn addressing the House, and not having concluded their speeches at the termination of the time allowed by Standing Order No. 257A—the honorable Members were given leave to continue their speeches.
  - Mr. Hughes addressing the House and not having concluded his speech-the House ordered that the Right Honorable Member have leave to continue his speech when the debate is resumed.
  - Ordered—That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for the next sitting.
