1. The House met, at eleven o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir Littleton Groom) took the Chair, and read Prayers.

PUBLIC WORKS COMMITTEE—REFERENCE OF WORK—TELEPHONE COMMUNICATION BETWEEN PERTH AND THE EASTERN STATES.—Mr. Gibson (Minister for Works and Railways) moved, pursuant to notice, That, in accordance with the provisions of the *Commonwealth Public Works Committee Act 1913–1921*, the following proposed work be referred to the Parliamentary Standing Committee on Public Works for investigation and report, viz. :—Establishment of Telephone Communication between Perth and the Eastern States.

Mr. Gibson having laid on the Table plans, &c., in connexion with the proposed work—

6. PUBLIC WORKS COMMITTEE—REFERENCE OF WORK—INSTITUTE OF ANATOMY, CANBERRA.—Mr. Aubrey Abbott (Minister for Home Affairs) moved, pursuant to notice, That, in accordance with the provisions of the *Commonwealth Public Works Committee Act 1913–1921*, the report of the Parliamentary Standing Committee on Public Works on the proposed construction of buildings and formation of zoological reservation at Canberra for the Institute of Anatomy (formerly known as the National Museum of Australian Zoology) shall, for the purpose of considering certain

modifications of the proposed work which appear to be necessary as the result of the development of the preliminary scheme originally submitted to the Committee, be remitted to the Committee for its further consideration and report.

7. PUBLIC WORKS COMMITTEE—REFERENCE OF WORK—ERECTION OF LABORATORIES AND AN ADMINISTRATIVE BLOCK FOR THE DIVISION OF ECONOMIC BOTANY, CANBERRA.—Mr. Aubrey Abbott (Minister for Home Affairs) moved, by leave, That, in accordance with the provisions of the *Commonwealth Public Works Committee Act 1913-1921*, the following proposed work be referred to the Parliamentary Standing Committee on Public Works for investigation and report, viz.:—The erection of Laboratories and an Administrative Block for the Division of Economic Botany, for the Council for Scientific and Industrial Research, Canberra.

Mr. Aubrey Abbott having laid on the Table plans, &c., in connexion with the work—

Debate ensued.

9. MESSAGE FROM THE DEPUTY OF THE GOVERNOR-GENERAL.—WINE OVERSEAS MARKETING BILL.—The following Message from His Excellency the Governor-General’s Deputy was presented, and the same was read by Mr. Speaker:—

D. R. S. DE CHAIR,
Deputy of the Governor-General.

Message No. 2.

In accordance with the requirements of Section 56 of the Constitution of the Commonwealth of Australia, the Deputy of the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act relating to the Export of Wine and for other purposes.
