- 3. ALTERATION OF DAY OF NEXT MEETING.-Mr. Bruce (Prime Minister) moved, That the House, at its rising, adjourn until Monday next at three o'clock p.m. Question-put and passed.
- 4. DRIED FRUITS EXPORT CHARGES BILL (1929).—Mr. Thomas Paterson (Minister for Markets and Transport), pursuant to leave given on the 13th instant, brought up a Bill intituled "A Bill for an Act to amend the Dried Fruits Export Charges Act 1924-1927", and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.
Ordered—That the second reading be made an Order of the Day for the next sitting.

- 5. DAIRY PRODUCE EXPORT CHARGES BILL (1929). -Mr. Thomas Paterson (Minister for Markets and Transport), pursuant to leave given on the 13th instant, brought up a Bill intituled "A Bill for an Act to amend the Dairy Produce Export Charges Act 1924," and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time. Ordered—That the second reading be made an Order of the Day for the next sitting.

6. CANNED FRUITS EXPORT CHARGES BILL (1929).-Mr. Thomas Paterson (Minister for Markets and Transport), pursuant to leave given on the 13th instant, brought up a Bill intituled "A Bill for an Act to amend the 'Canned Fruits Export Charges Act 1926'," and moved, That it be now read a first time.
