MINISTERIAL STATEMENT—PERMANENT COURT OF INTERNATIONAL JUSTICE.—Mr. Bruce (Prime Minister), by leave, made a Ministerial Statement with reference to the decision of the Governments of the British Empire to sign the optional clause of Article 36 of the Statute of the Permanent Court of International Justice.

- 7. MARITIME INDUSTRIES BILL.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—Debate resumed.
 - Mr. Grosvenor Francis moved, That the debate be now adjourned. Question—That the debate be now adjourned—put and passed.
