Commonwealth of Australia to wit. STONEHAVEN Governor-General. By His Excellency the Right Honorable John Lawrence, Baron Stonehaven, a Member of His Majesty's Most Honorable Privy Council, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, member of the Distinguished Service Order, Governor-General and Commander-in-Chief in and over the Commonwealth of Australia.

Given under my hand and the Seal of the Commonwealth of Australia, at Canberra, this thirteenth day of (L.S.) September, in the year of Our Lord One thousand nine hundred and twenty-nine, and in the twentieth year of His Majesty's reign.
