1. The House met, at eleven o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Norman J. O. Makin) took the Chair, and read Prayers.

- LEAVE OF ABSENCE TO MEMBER (MR. FENTON).—Mr. Scullin (Prime Minister) moved, by leave, That leave of absence for two months be given to the Minister for Trade and Customs (Mr. Fenton), on the ground of urgent public business. Question—put and passed.
- 3. LEAVE OF ABSENCE TO MEMBER (MR. KILLEN).---Mr. Earle Page moved, by leave, That leave of absence for one month be given to the honorable Member for Riverina (Mr. Killen), on the ground of ill-health. Question---put and passed.

5. MESSAGE FROM THE GOVERNOR-GENERAL.—SEAT OF GOVERNMENT (ADMINISTRATION) BILL (1930).— The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker :—

In accordance with the requirements of section 56 of the Constitution of the Commonwealth of Australia, the Governor General recommends to the House of Representatives that an appropriation of revenue and moneys be made for the purposes of a Bill for an Act to amend the Seat of Government (Administration) Act 1910, and for other purposes.

Mr. Blakeley (Minister for Home Affairs) moved, That it is expedient that an appropriation of revenue and moneys be made for the purposes of a Bill for an Act to amend the *Scat of Government* (Administration) Act 1910, and for other purposes.

Question put and passed.

Resolution to be reported.

The House resumed ; Mr. McGrath reported accordingly.

The said Resolution was read, and, on the motion of Mr. Blakeley, was adopted by the House.

Debate resumed. Mr. West moved, That the debate be now adjourned.

Question-That the debate be now adjourned-put and passed.

- 7. MINISTERIAL STATEMENT-INCREASE IN EXCISE DUTY ON WINE. Mr. Scullin (Prime Minister), by leave, made a Ministerial Statement with reference to the effect of the increase in the Excise Duty on Wine.
- 8. MESSAGE FROM THE SENATE.—LAND TAX ASSESSMENT BILL (1930).—Mr. Speaker announced the receipt of the following Message from the Senate :—

MR. SPEAKER,

The Senate returns to the House of Representatives the Bill for "An Act to amend section three, paragraph. (h) of section thirteen, and section twenty-eight of the 'Land Tax Assessment Act 1910-1928'", and acquaints the House that the Senate has agreed to the Bill with the Amendments indicated by the annexed Schedule, in which Amendments the Senate requests the concurrence of the House of Representatives.

Mr. Forde then brought up the Bill accordingly, and moved, That it be now read a first time.

Question-put and passed.-Bill read a first time.

Mr. Forde moved, by leave, That the Bill be now read a second time. Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole, and agreed to. Bill to be reported without amendment.

The House resumed; Mr. Yates reported accordingly.

On the motion of Mr. Forde, the House adopted the Report, and, by leave, the Bill was read a third time.
