1. **The House** met, at eleven o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Norman J. O. Makin) took the Chair, and offered Prayers.
2. **MINISTERIAL STATEMENT—FOREIGN MINERS AT MT. ISA, QUEENSLAND.**—Mr. Blakeley (Minister for Home Affairs), by leave, made a Ministerial Statement with reference to allegations in a certain newspaper regarding the arrival from the United States of America of a number of Miners for work at Mt. Isa, Queensland.
3. **BANKRUPTCY BILL (1930).**—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—
Debate resumed.
Question—put and passed.—Bill read a second time.
Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clause 1 agreed to.

Clause 2 debated and agreed to.

Clause 3 debated and agreed to.

New Clause—

On the motion of Mr. Brennan (Attorney-General), the following new clause was inserted in the Bill, after debate:—

1A. Section six of the Principal Act is amended by inserting in paragraph (b), after the words "Insolvency Act," the words "or instituted after the commencement of this Act in relation to any such proceedings,"

Saving of rights
under State

Title agreed to.

Bill to be reported with an amendment.

The House resumed; Mr. McGrath reported accordingly.

On the motion of Mr. Brennan, by leave, the House adopted the Report, and, by leave, the Bill was read a third time.

4. **CENTRAL RESERVE BANK BILL.**—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—
Debate resumed.
Mr. Earle Page addressing the House, and not having concluded his speech at the termination of the time allowed by Standing Order No. 257A—the Right Honorable Member was given leave to continue his speech.
Mr. Lazzarini addressing the House, and not having concluded his speech—the House ordered that the honorable Member have leave to continue his speech when the debate is resumed.
Ordered—That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for the next sitting.
