THURSDAY, 4TH DECEMBER, 1930.

1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable Norman J. O. Makin) took the Chair, and offered Prayers.
2. MINISTERIAL STATEMENT—ADVANCE BY COMMONWEALTH BANK ON WHEAT.—Mr. Forde (Honorary Minister), by leave, made a Ministerial Statement regarding the arrangements made by the Government with the Commonwealth Bank for an advance in respect of this season's wheat.
3. LEAVE OF ABSENCE TO MEMBERS (MR. SCULLIN, MR. BRENNAN AND MR. PARKER MOLONEY).—Mr. Fenton (Acting Prime Minister) moved, by leave, That leave of absence for two weeks be given to the Prime Minister (Mr. Scullin), the Attorney-General (Mr. Brennan), and the Minister for Markets and for Transport (Mr. Parker Moloney), on the ground of urgent public business.  
Question—put and passed.
4. LEAVE OF ABSENCE TO MEMBER (MR. COLEMAN).—Mr. Fenton (Acting Prime Minister) moved, by leave, That leave of absence for two weeks be given to the honorable Member for Reid (Mr. Coleman), on the ground of urgent public business.  
Question—put and passed.
5. LEAVE OF ABSENCE TO MEMBERS (MR. WEST AND MR. JAMES).—Mr. Fenton (Acting Prime Minister) moved, by leave, That leave of absence for two weeks be given to the honorable Member for East Sydney (Mr. West) and the honorable Member for Hunter (Mr. James), on the ground of ill-health.  
Question—put and passed.
6. THE LATE SIR NEVILLE HOWSE.—Mr. Speaker informed the House that he had received from Lady Howse a letter thanking the House for its Resolution of sympathy.

(In the Committee.)

Clause 1 debated and agreed to.

Remainder of Bill, by leave, taken as a whole, and agreed to.

Bill to be reported without amendment.

The House resumed ; Mr. McGrath reported accordingly.

On the motion of Mr. Lyons (Acting Treasurer), the House adopted the Report, and, by leave, the Bill was read a third time.

10. REPRESENTATION BILL (1930).—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—  
Debate resumed.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clause 1 debated and agreed to.

Clause 2 debated and agreed to.

Proposed new clause—

Mr. Thomas Paterson proposed to move, That the following new clause be added to the Bill :—

3. Paragraph (a) of section ten of the *Representation Act* 1905 is amended by adding after the word “Senators” the words “plus one”.*Temporary Chairman's Ruling.*—The Temporary Chairman (Mr. Yates) ruled that such a new clause would be out of order, as it would be outside the scope of the Bill.

Title agreed to.

Bill to be reported without amendment.

The House resumed ; Mr. Yates reported accordingly.

On the motion of Mr. Blakeley (Minister for Home Affairs), the House adopted the Report, and, by leave, the Bill was read a third time, after debate.

11. POSTPONEMENT OF ORDERS OF THE DAY.—Ordered—That Orders of the Day Nos. 1 and 4, Government Business, be postponed until after Order of the Day No. 5.

12. WAYS AND MEANS—INCOME TAX BILL (No. 2) (1930).—The House, according to Order, resolved itself into the Committee of Ways and Means.

4th December, 1930.

(In the Committee.)

Mr. Lyons (Acting Treasurer) moved—

(1) That the further tax imposed by section seven of the *Income Tax Act* 1930 on certain income derived from personal exertion, be increased from ten per centum of the amount of tax payable under the preceding provisions of that Act on the income so derived, to fifteen per centum of that amount.

(2) That in addition to any tax (including additional tax, super-tax and further tax) payable under sections three to seven (inclusive) of the *Income Tax Act* 1930, there shall be payable upon the taxable income derived by any person—

(a) from property;

(b) by way of interest, dividends, rents or royalties, whether derived from personal exertion or from property; and

(c) in the course of carrying on a business, where the income is of such a class that, if derived otherwise than in the course of carrying on a business, it would be income from property,

a further tax of seven and one-half per centum of the amount of that taxable income.

(3) That the tax provided for in the last preceding clause of this resolution shall not—

(a) apply to income which is assessable to a member or shareholder of a company under sub-paragraph (i) or (ii) of paragraph (b) of section sixteen of the *Income Tax Assessment Act* 1922-1930 and which is credited, paid or distributed by that company out of income upon which tax is payable by that company under this resolution; and

(b) if payable by a company—be included in the calculation, for the purposes of the proviso following sub-paragraph (iii) of paragraph (b) of section sixteen of the *Income Tax Assessment Act* 1922-1930, of the rate of tax paid or payable by that company.

(4) That sub-sections (2.) to (13.) inclusive of section thirteen of the *Income Tax Assessment Act* 1922-1930 shall not apply to tax provided for in clause (2) of this resolution.

(5) That the tax provided for in the foregoing provisions of this resolution shall be levied and paid for the financial year beginning on the first day of July One thousand nine hundred and thirty.

(6) That the foregoing provisions of this resolution shall also apply to all assessments for financial years subsequent to that beginning on the first day of July One thousand nine hundred and thirty made prior to the passing of the Act for the levying and payment of the income tax for the financial year beginning on the first day of July One thousand nine hundred and thirty-one.

Debate ensued.

Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Crouch reported accordingly.

Resolved—That the House will, at the next sitting, again resolve itself into the said Committee.

13. NORTHERN TERRITORY (ADMINISTRATION) BILL (1930).—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—

Debate resumed.

Mr. Mackay moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

14. ADJOURNMENT.—Mr. Fenton (Acting Prime Minister) moved, That the House do now adjourn.

Debate ensued.
