Navigation Act—Regulations Amended, &c.—Statutory Rules 1931, Nos. 20, 24. Papua Act—Ordinance of 1930—No. 3—Police Offences. Public Service Act-Regulations Amended-Statutory Rules 1931, No. 29.
- 4. DISTILLATION BILL (1931).-The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-Debate resumed.
