TUESDAY, 15TH NOVEMBER, 1932.

1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable G. H. Mackay) took the Chair, and read Prayers.
2. PAPERS.—The following Papers were presented, pursuant to Statute—  
Defence Act—Regulations Amended—Statutory Rules 1932, No. 125.  
Northern Territory Acceptance Act and Northern Territory (Administration) Act—  
Ordinance of 1932—No. 20—Licensing.  
Public Service Ordinance—Regulations Amended.
3. JUDICIARY BILL (1932).—Mr. Marr (Minister for Health) for Mr. Latham (Attorney-General) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the *Judiciary Act* 1903–1927.  
Question—put and passed.  
Mr. Marr then brought up the Bill accordingly, and moved, That it be now read a first time.  
Question—put and passed.—Bill read a first time.  
Ordered—That the second reading be made an Order of the Day for the next sitting.
4. CRIMES BILL (No. 2) (1932).—Mr. Marr (Minister for Health) for Mr. Latham (Attorney-General) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the *Crimes Act* 1914–1932.  
Question—put and passed.  
Mr. Marr then brought up the Bill accordingly, and moved, That it be now read a first time.  
Question—put and passed.—Bill read a first time.  
Ordered—That the second reading be made an Order of the Day for the next sitting.
5. UNITED KINGDOM AND AUSTRALIA TRADE AGREEMENT BILL.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—  
*And on the Amendment moved thereto by Mr. Scullin, viz. :—That all the words after "That" be omitted and the following words be inserted in lieu thereof:—"the Bill be withdrawn and negotiations opened for a new agreement embodying concessions to Australian producers and preferences to Great Britain on specified items without endangering our protective policy or depriving Parliament of its power to give effect to the will of the people on general tariff policy"*—  
Debate resumed.  
Mr. Maxwell addressing the House and not having concluded his speech at the termination of the time allowed by Standing Order No. 257B—  
Ordered—That the honorable Member have leave to continue his speech.  
Debate continued.  
Question—That the words proposed to be omitted stand part of the question—put.
