WAR SERVICE HOMES AGREEMENT BILL (1932).—Mr. Josiah Francis (Minister administering War Service Homes), pursuant to leave given on the 23rd instant, brought up a Bill intituled "A Bill for an Act to approve an Agreement made between His Majesty's Government of the Commonwealth of Australia and the Commissioners of the State Savings Bank of Victoria and for other purposes", and moved, That it be now read a first time.

- 6. INCOME TAX ASSESSMENT BILL (1932).—Mr. Lyons (Treasurer) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the *Income Tax Assessment Act* 1922–1931. Question—put and passed.
- 7. FINANCIAL RELIEF BILL.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time— Debate resumed.
 - Mr. Beasley moved, as an amendment, That all the words after "That" be omitted with a view to the insertion of the following words in place thereof :—" there shall be no remission of land taxation until the Government is prepared to introduce legislation to restore to invalid and old-age pensioners the benefits taken from them by the *Financial Emergency Act*".
