ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION .- Mr. Scullin (Leader of the Opposition) rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The necessity for an inquiry into banking operations and their effect upon Australia's economic position ".
 - Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly---Mr. Scullin moved, That the House do now adjourn.
 - Debate ensued.
