- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable G. H. Mackay) took the Chair, and read Prayers.
- 2. PRINTING COMMITTEE-FOURTH REPORT.-Mr. E. F. Harrison, Vice-Chairman, brought up the Fourth Report from the Printing Committee (sitting in conference with the Printing Committee of the Senate).

The Report was read by the Clerk, as follows :----

The Printing Committee have the honour to report that they have met in Conference with the Printing Committee of the Senate.

The Joint Committee, having considered the Papers presented to Parliament since the last meeting of the Committee, recommend that the following be printed :

4. PROPOSED ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION .--- Mr. Blakeley proposing to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The action of the Government in withholding wages from the employees of the Commonwealth Railways which had been awarded them by an award of the Commonwealth Court of Conciliation and Arbitration"

Point of Order .- Mr. Latham (Attorney-General) raised a Point of Order that, as the matter was the subject of legal proceedings, that the Court of Conciliation and Arbitration had reserved judgment upon it, and that it was also before the High Court in another aspect, the subject matter was sub *judice* and could not be debated.

Speaker's Ruling.-Mr. Speaker ruled that in the circumstances disclosed by the Attorney-General the subject appeared to be sub judice, and could not, therefore, be debated.

- 6. AUSTRALIAN ANTARCTIC TERRITORY ACCEPTANCE BILL.—The Order of the Day having been read for the second reading—Mr. Latham (Minister for External Affairs) moved, That the Bill be now read a second time.

Debate ensued. Question—put and passed.—Bill read a second time. Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Bill, by leave, taken as a whole, and agreed to. Bill to be reported without amendment.

The House resumed ; Mr. Bell reported accordingly. On the motion of Mr. Latham, the House adopted the Report, and, by leave, the Bill was read a third time.

- 11. TOBACCO-TARIFF BOARD REPORT-MOTION FOR PRINTING PAPER.—The Order of the Day having been read for the resumption of the debate on the following motion of Sir Henry Gullett, That the Paper [presented on the 2nd March, 1932], viz. :--

Tariff Board-Report and Recommendation-Tobacco-

be printed, and on the Amendment moved thereto by Mr. Forde, viz. :--That the following words be added to the motion :---" and that the Government reconsider its action with a view to affording Australian tobacco-growers the same margin of protection as that given by the previous Government ; and that Parliament be granted an early opportunity to determine the question so as to remove the uncertainty now prevailing in the industry." ; and on the Amendment to the proposed Amendment moved by Mr. Earle Page, viz. :--That all words in the proposed amendment after the word " that " (first occurring) be omitted and the following words be inserted in place thereof :---" in the opinion of this House, the Government should reconsider the proposals submitted by the tobacco-growers that the rates of excise duty should be, on
