Vote—" Postmaster-General's Department, £830,840"—debated and agreed to. Vote—" Northern Territory, £22,000"—debated and agreed to.

Vote-" Federal Capital Territory, £115,200"-agreed to.

Mr. Casey (Assistant Minister) moved, That there be granted to His Majesty to the service of the year 1933-34, for the purposes of Additions, New Works, Buildings, &c., a sum not exceeding £1,624,880.

Question—put and passed.

Resolution to be reported, and leave asked to sit again.

The House resumed; Mr. Bell reported accordingly.

10. Appropriation (Works and Buildings) Bill 1933-34.—Mr. Casey (Assistant Minister) then brought up a Bill intituled "A Bill for an Act to grant and apply a sum out of the Consolidated Revenue Fund for the service of the year ending the thirtieth day of June One thousand nine hundred and thirty-four for the purposes of Additions, New Works. Buildings, &c., and to appropriate such sum," and moved, That it be now read a first time.

Question--put and passed.—Bill read a first time. Mr. Casey moved, That the Bill be now read a second time.

Question--put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clauses 1 to 3 agreed to. Schedule agreed to. Preamble agreed to. Title agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Bell reported accordingly.

On the motion of Mr. Casey, the House adopted the Report, and the Bill was read a third time.

11. FINANCIAL RELIEF BILL (1933).—Mr. Lyons (Treasurer), pursuant to leave given on the 5th instant, brought up a Bill inituled "A Bill for an Act to provide relief to Taxpayers, to amend laws relating to Financial Emergency, and for other purposes," and moved, That it be now read a first time. Question—put and passed.—Bill read a first time.

Mr. Lyons moved, by leave, That the Bill be now read a second time.

Mr. Scullin moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for the next sitting.

12. Message from the Governor-General.—Loan Fund Expenditure Bill.—The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker:

In accordance with the requirements of section 56 of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue and moneys be made for the purposes of a Bill for an Act to authorize the Expending of a certain Sum of Money.

Mr. Casey then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Casey moved, That the Bill be now read a second time.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Bill, by leave, taken as a whole, and agreed to.
