Page 3, line 32, after “or” insert “, where no such form is prescribed, shall be in such form as is authorized by the Commissioner, and, in either case, shall set forth such information as”.  
Page 3, line 35, after “prescribed” insert “or authorized”.

“(3A.) Any return furnished before the date upon which this Act receives the Royal Assent, by any person specified in sub-section (1.) of this section of any goods so specified, and made or purporting to be made under any one or more of the Sales Tax Assessment Acts, shall be deemed to be a return furnished under this section.”.

Clause 6 agreed to.

Clause 7—

Mr. Blackburn moved, as an amendment, That the following new sub-clause be added :—

“(3.) In any prosecution for an offence against paragraph (c) of sub-section (1.)—

(i) of this section, or

(ii) of section forty-five of the *Sales Tax Assessment Act (No. 1) 1930-1934*,

it shall be a defence if the defendant proves—

(a) that he has not been convicted previously of any offence against this Act or against any *Sales Tax Assessment Act*; and

(b) that, as to so much of any return or answer as has been prepared by him personally, the false particulars were given or (as the case may be) the false statement was made through ignorance or inadvertence; and

(c) that, as to so much of any return or answer as has not been prepared by him personally, the false particulars were given or (as the case may be) the false statement was made through—

(i) ignorance or inadvertence on his own part; or

(ii) reasonable reliance upon the accuracy and competence of the person preparing the return or answer; or

(iii) both (i) and (ii).”.

Debate ensued.

Amendment withdrawn, by leave.

On the motion of Mr. Casey, the following amendment was made :—

Page 4, at the end of the clause add the following sub-clause :—

“(3.) In any prosecution, for an offence against paragraph (c) of sub-section (1.) of this section, of any person who has not previously been convicted of an offence against this Act or against any Sales Tax Assessment Act, it shall be a defence if the defendant proves—

(a) that the return or answer to which the prosecution relates was prepared or made by him personally; and

(b) that the false particulars were given or (as the case may be) the false statement was made through ignorance or inadvertence.”.

Clause, as amended, agreed to.

Clause 8 debated and agreed to.

Clause 9 agreed to.

Clause 10—

Mr. Nairn moved, as an amendment, That all words after the word “payable,” (page 5, line 37) to the end of the clause be omitted.

Amendment negatived.

Clause agreed to.

Claus 11 to 14 agreed to.

Title agreed to.

Bill to be reported with amendments.
