And Mr. Curtin (Leader of the Opposition) having seconded the motion, and other honorable Members having addressed the House in support thereof, and all Members present having risen, in silence-Question—passed.

Resolved—That the foregoing Resolution be transmitted to the widow of the deceased cx-Member together with a copy of the speeches delivered thereon.

Mr. Parkhill (Minister for Defence) moved, That there be granted to His Majesty to the service of the year 1935-36, for the purposes of Additions, New Works, Buildings, &c., a sum not exceeding £3,352,230.

Question—put and passed.

Resolution to be reported, and leave asked to sit again.

The House resumed; Mr. Prowse reported accordingly.

Resolved—That the House will, at a later hour this day, again resolve itself into the said Committee.

6. Suspension of Standing Orders.-Mr. Parkhill (Minister for Defence) moved, pursuant to contingent notice, That the Standing Orders be suspended, to enable the remaining stages to be passed without delay.

Question—put and passed.

- 7. Supply Resolution.—The Resolution reported from the Committee of Supply was read, and, on the motion of Mr. Parkhill (Minister for Defence), was adopted by the House.
- 8. Ways and Means Resolution—Estimates—Additions, New Works, Buildings, etc., 1935-36.— The House, according to Order, resolved itself into the Committee of Ways and Means.

Additions, New Works, Buildings, etc., 1935-36.

Mr. Parkhill (Minister for Defence) moved, That, towards making good the Supply granted to His Majesty for Additions, New Works, Buildings, &c., for the year 1935-36, there be granted out of the Consolidated Revenue Fund a sum not exceeding £3,352,230.

Question—put and passed.

Resolution to be reported, and leave asked to sit again.

The House resumed; Mr. Prowse reported accordingly.

Resolved—That the House will, at a later hour this day, again resolve itself into the said Committee. The Resolution reported from the Committee was read, and, on the motion of Mr. Parkhill, was adopted by the House.

Ordered-That Mr. Parkhill and Mr. Casey do prepare and bring in a Bill to carry out the foregoing Resolution.

9. Appropriation (Works and Buildings) Bill 1935-36.—Mr. Parkhill (Minister for Defence) then brought up a Bill intituled "A Bill for an Act to grant and apply a sum out of the Consolidated Revenue Fund for the service of the year ending the thirtieth day of June One thousand nine hundred and thirtysix for the purposes of Additions, New Works, Buildings, &c., and to appropriate such sum", and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Parkhill moved, That the Bill be now read a second time.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole, and agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Prowse reported accordingly.

On the motion of Mr. Parkhill, the House adopted the Report, and the Bill was read a third time.

10. ITALO ABYSSINIAN DISPUTE—MINISTERIAL STATEMENT—MOTION FOR PRINTING PAPER.—The Order of the Day having been read for the resumption of the debate on the following motion of Mr. Lyons (Prime Minister), That the Paper [presented on the 23rd September last], viz.:—

Italo-Abyssinian Dispute-Ministerial Statement-

be printed—and on the amendment moved thereto by Mr. Beasley, viz.:—That all the words after "That" be omitted with a view to the insertion of the following words in place thereof:— "this Parliament records grave concern and its profound horror at the prospect of a second world war developing out of the conflict of Imperial trading interests, and expresses its unflinching determination not to allow Australia to become involved, under any circumstances, notwithstanding any decision recorded at the League of Nations Council.

It views with alarm the action of the British Admiralty in despatching H.M.A.S. Australia, with an Australian crew, to the war zone, and requests the immediate recall of that vessel to

Australian waters under the direct control of the Federal Defence Department.

It formally declares the neutrality of Australia, and instructs the Government to take all

necessary steps to preserve such neutrality.

It declares that it will not support the application of sanctions under Article 16 or contribute a quota of military, naval and air force strength to an armed force for such purposes, as such action would involve Australia in war."—

Debate resumed.

Mr. Parkhill (Minister for Defence) moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for a later hour this day.
