### WEDNESDAY, 29TH APRIL, 1936.

- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable G. J. Bell) took the Chair, and read Prayers.
- 2. DEATH OF MR. E. JOWETT.—Mr. Lyons (Prime Minister) moved, by leave, That this House expresses its deep regret at the death of Mr. Edmund Jowett, a former Member of the House of Representatives, places on record its appreciation of his public service, and tenders its deep sympathy to the members of his family in their bereavement.

And Mr. Curtin (Leader of the Opposition) having seconded the motion, and Mr. Thomas Paterson having addressed the House in support thereof, and all Members present having risen, in silence—Question—passed.

Question—passed. Resolved—That the foregoing Resolution be transmitted to the members of the late Mr. Jowett's family, together with a copy of the speeches delivered thereon.

3. DEATH OF KING GEORGE V., AND ACCESSION OF KING EDWARD VIII.—REFLY TO RESOLUTIONS.—Mr. Speaker informed the House that he had received the following communication from His Excellency the Governor-General :—
