'(7A.) The member appointed to represent proprietary and privately owned wineries and distilleries in the State of Western Australia shall be appointed upon the nomination of the associations in that State affiliated with the Federal Viticultural Council of Australia.".

and in respect of which benefit the Collector is not satisfied that Colonial light dues have already

been paid in some part of His Majesty's dominions.

3. That where, by Order in Council His Majesty fixes any rate of Colonial light dues in substitution for either of the rates hereinbefore specified, and the Governor-General, by regulation made under the Colonial Light Dues (Rates) Act 1932 as amended by the Act passed to give effect to this Resolution, authorizes the imposition in the Commonwealth of Colonial light dues at the rate so fixed, Colonial light dues shall be imposed in the Commonwealth at the rate so fixed in lieu of the rate hereinbefore specified for which the rate so fixed is in substitution.

4. That Colonial light dues imposed under the Colonial Light Dues (Rates) Act 1932 as amended by the Act passed to give effect to this Resolution shall be payable in currency of the United Kingdom or in Australian currency of such amount as, having regard to the rate of exchange prevailing at the time of payment, represents the equivalent, in currency of the United

Kingdom, of the dues so imposed.

5. That, for the purposes of this Resolution, the term "the Collector" shall have the same meaning as in the Colonial Light Dues Collection Act 1932–1934.
