- 14. LONDON NAVAL TREATY BILL (1937).-SENATE'S REQUEST FOR RESUMPTION OF CONSIDERATION.--The Order of the Day having been read for the consideration of the Message from the Senate requesting the resumption by the House of the consideration of this Bill, which was transmitted to the House for concurrence during the last Session of the Parliament, and the proceedings on which were interrupted by the Prorogation of the Parliament-
 - Mr. Menzies (Attorney-General) moved, That the request of the Senate, contained in its Message No. 2 for the resumption by the House of the consideration of the London Naval Treaty Bill, be complied with, and that a Message be transmitted to the Senate acquainting it therewith, and that the second reading of the Bill (the stage which the Bill had reached last Session), be made an Order of the Day for the next sitting.

Question—put and passed.

15. ADJOURNMENT-COUNT-OUT.-Mr. Earle Page (Acting Prime Minister) moved, That the House do now adjourn.

Debate ensued.

Mr. Baker addressing the House-
