In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the *Defence Equipment Act* 1928.

Governor-General.

In accordance with the requirements of Section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to grant and apply out of the Consolidated Revenue Fund the sum of One million pounds for the purpose of Post Office Works.

- 7. Australian Soldiers' Repatriation Bill (No. 2) (1937).—Mr. Menzies (Attorney-General) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend sections twenty and twenty-one of the Australian Soldiers' Repatriation Act 1920-1937.

Question—put and passed.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purpose of a Bill for an Act to provide for the Payment of Bounties on certain Goods the Produce of Manufacture of the Territory of Papua and on certain Goods the Produce or Manufacture of the Territory of New Guinea.

The Senate returns to the House of Representatives the Bill for "An Act to grant and apply a sum out of the Consolidated Revenue Fund for the service of the year ending the thirtieth day of June One thousand nine hundred and thirty-eight", and acquaints the House that the Senate has agreed to the Bill without requests.
