- 1. The House met, at eleven o'clock a.m., pursuant to adjournment .-- Mr. Speaker (the Honorable G. J. Bell) took the Chair, and read Prayers.
- 2. CAPITAL OF NEW GUINEA-MINISTERIAL STATEMENT.-Mr. Hughes (Minister in charge of Territories), by leave, made a Ministerial Statement informing the House of the decision of the Government to transfer the site of the administrative head-quarters of the Mandated Territory of New Guinea from Rabaul to Salamaua, and of the financial proposals to cover the cost of the transfer and other matters connected therewith.
- 3. PAPERS.—The following Papers were presented, by command of His Excellency the Administrator— Ecuador—Treaty regarding Extradition—Supplementary Convention between United Kingdom, Australia, New Zealand and South Africa, and Ecuador (Quito, 4th June, 1934).

- 10. EXPORT OF IRON ORE-MINISTERIAL STATEMENT.-Mr. Lyons (Prime Minister), by leave, made a Ministerial Statement informing the House of the decision of the Government to permit the export under licence and subject to conditions of certain quantities of iron ore which were arranged for prior to the announcement of the 19th May last.
- 11. ADJOURNMENT.-Mr. Lyons (Prime Minister) moved, That the House do now adjourn.

Debate ensued. Question—put and passed.

- And then the House, at twenty-eight minutes past five o'clock p.m., adjourned until Tuesday next at three o'clock p.m.
