7. MINISTERIAL CHANGES AND FORMATION OF NEW GOVERNMENT-MINISTERIAL STATEMENT.-Sir Earle Page (Prime Minister) informed the House that, following the death of the Right Honorable J. A. Lyons on Friday, the 7th instant, His Excellency the Governor-General had appointed him Prime Minister of the Commonwealth. His Excellency had also confirmed Ministers in their existing portfolios.

Sir Earle Page also announced that the resignation of Mr. Menzies of the offices of Attorney-General and Minister for Industry was accepted by His Excellency the Governor-General on the 20th March last, and that Mr. Hughes (Minister for External Affairs) was, on the same date, appointed by His

Excellency to be Attorney-General and Minister for Industry.

Sir Earle Page also informed the House that Mr. John Lawson had resigned his appointments as Parliamentary Secretary to the Treasurer and Parliamentary Secretary to the Minister for Industry.

8.
