1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable G. J. Bell) took the Chair, and read Prayers.
2. BROADCASTING OF OVERSEAS WAR NEWS—MINISTERIAL STATEMENT.—Sir Henry Gullett (Minister for Information), by leave, made a Ministerial Statement informing the House of the arrangements made at the conference held in Melbourne on Monday last for the broadcasting of overseas war news by broadcasting stations in Australia.
Mr. Curtin (Leader of the Opposition) and Mr. Cameron, by leave, also made Statements with reference to the matter.
3. PAPER.—The following Paper was presented, by command of His Excellency the Governor-General—
High Commissioner for Australia in London—Report for 1938.
Ordered to lie on the Table.
4. PRECEDENCE TO GOVERNMENT BUSINESS.—Mr. Menzies (Prime Minister) moved, pursuant to notice, That Government Business shall take precedence over General Business at the next sitting.
Question—put and passed.
5. SUSPENSION OF STANDING ORDER No. 70.—Mr. Menzies (Prime Minister) moved, pursuant to notice, That Standing Order No. 70 (eleven o'clock rule) be suspended for the remainder of this week.
Debate ensued.
Question—put and passed.
6. AUSTRALIAN BROADCASTING COMMISSION BILL 1939.—Mr. Harrison (Postmaster-General) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the *Australian Broadcasting Commission Act* 1932.
Question—put and passed.
Mr. Harrison then brought up the Bill accordingly, and moved, That it be now read a first time.
Question—put and passed.—Bill read a first time.
Ordered—That the second reading be made an Order of the Day for the next sitting.
7. INCOME TAX ASSESSMENT BILL 1939.—Mr. Spender (Minister assisting the Treasurer) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the *Income Tax Assessment Act* 1936-1938.
Question—put and passed.
Mr. Spender then brought up the Bill accordingly, and moved, That it be now read a first time.
Question—put and passed.—Bill read a first time.
Mr. Spender moved, by leave, That the second reading be made an Order of the Day for a later hour this day.
Question—put and passed.
8. SALES TAX EXEMPTIONS BILL 1939.—Mr. Spender (Minister assisting the Treasurer) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the *Sales Tax Exemptions Act* 1935-1938 to exempt certain Defence Supplies and Plant and Building Materials for use in connexion with the manufacture of Defence Supplies.
Question—put and passed.
Mr. Spender then brought up the Bill accordingly, and moved, That it be now read a first time.
Question—put and passed.—Bill read a first time.
Mr. Spender moved, by leave, That the second reading be made an Order of the Day for a later hour this day.
Question—put and passed.
9. WAYS AND MEANS—CUSTOMS TARIFF AMENDMENTS (Nos. 7 and 9).—The House, according to Order, resolved itself into the Committee of Ways and Means.

12. **POSTPONEMENT OF ORDER OF THE DAY.**—Ordered—That Order of the Day No. 2, General Business, be postponed until after Order of the Day No. 3.

13. **SUPPLY AND DEVELOPMENT BILL (No. 2) 1939.**—The Order of the Day having been read for the second reading—Mr. Holloway moved, That the Bill be now read a second time.

Debate ensued.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Clauses 1 and 2 agreed to.

Clause 3—

On the motion of Mr. Holt (Minister assisting the Minister for Supply and Development), the following amendment was made, after debate :—Page 1, omit all words after “amended” (line 12) to the end of the clause, insert “—

(a) by omitting from sub-section (3.) the definition of ‘employee’ and inserting in its stead the following definition :—

“employee” means employee not being a person who is an officer within the meaning of the *Commonwealth Public Service Act 1922-1937* ; and

(b) by omitting from the definition of ‘trade union’ in sub-section (3.) the words ‘but does not include an association of employees in the Public Service’.

Clause, as amended, agreed to.

Title agreed to.

Bill to be reported with an amendment.

The House resumed ; Mr. Nairn reported accordingly.

On the motion of Mr. Holloway, by leave, the House adopted the Report, and, by leave, the Bill was read a third time.

14. **REGULATIONS BILL 1939.**—The Order of the Day having been read for the second reading—Mr. Blackburn moved, That the Bill be now read a second time.

Debate ensued.

Mr. Lane moved, That the debate be now adjourned.

15. **AIR EXPEDITIONARY FORCE—MINISTERIAL STATEMENT.**—Mr. Menzies (Prime Minister), by leave, made a Ministerial Statement announcing that the Government had decided to offer to the United Kingdom Government the services of personnel for six air squadrons, consisting of four bomber squadrons and two two-seater fighting squadrons.
