# WEDNESDAY, 25TH MARCH, 1942.

- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable W. M. Nairn) took the Chair, and read Prayers.
- 2. MESSAGE FROM THE GOVERNOR-GENERAL .- ASSENT TO BILL .- The following Message from His Excellency the Governor-General was received, and was read by Mr. Speaker :-

GOWRIE,

Governor-General.

Message No. 57.

A Proposed Law initialed "Loan Act 1942" as finally passed by the Senate and the House of Representatives of the Commonwealth, having been presented to the Governor-General for the Royal Assent, His Excellency has, in the name and on behalf of His Majesty, assented to the said Law.

- 3. PETITION .- Mr. Falstein presented a Petition from certain electors of the Division of Watson, praying that enemy aliens, whether naturalized or not, be interned immediately. Petition received and read.
- 4. VISIT OVERSEAS OF MR. EVATT-MINISTERIAL STATEMENT.-Mr. Curtin (Prime Minister), by leave. made a Ministerial Statement informing the House of the visit overseas on a special mission of the Minister for External Affairs and Attorney-General (Mr. Evatt). Mr. Curtin announced that during Mr. Evatt's absence the Minister for Supply and Development would act as Attorney-General and the Prime Minister would act as the Minister for External Affairs.
- 5. ADVISORY WAR COUNCIL—MINISTERIAL STATEMENT.—Mr. Curtin (Prime Minister) informed the House that the Treasurer (Mr. Chifley) had been sworn in as a member of the Advisory War Council.
- 6. PROGRESS OF WAR-MINISTERIAL STATEMENT, 25TH MARCH, 1942-MOTION FOR PRINTING PAPER.-Mr. Curtin (Prime Minister), by leave, made a Ministerial Statement reviewing the progress of the war and informing the House of certain arrangements made in connexion with the control of the allied forces in Australia. Mr. Curtin then, by command of His Excellency the Governor-General, laid upon the Table the following Paper :--

Mr. Fadden (Leader of the Opposition) moved, That the debate be now adjourned.

- 8. SOCIAL SECURITY-JOINT COMMITTEE-INTERIM REPORTS .- Mr. Barnard, Chairman, brought up the Second and Third Interim Reports from the Joint Committee on Social Security, and moved, That the Papers be printed.
  - Question-put and passed.
- 9. AUSTRALIAN MILITARY FORCES IN DISTANT CENTRES-MINISTERIAL STATEMENT.-Mr. Forde (Minister for the Army), by leave, made a Ministerial Statement with reference to allegations of the posting to distant military centres of inadequately trained members of the Australian Military Forces between the ages of eighteen and twenty.
- 10. Appointment of Mr. Casey as Minister of State of the United Kingdom-Motion for Printing PAPER .- Mr. Curtin (Prime Minister) laid upon the Table, by command of His Excellency the Governor-General, the following Paper :-

Documents relating to appointment of His Majesty's Australian Minister at Washington (Right Honorable R. G. Casey) as Minister of State of the United Kingdom.

Mr. Fadden (Leader of the Opposition), by leave, made a Statement with reference to the appointment. F.6316.

Mr. Calwell moved, That the Paper be printed. Debate ensued.

- 12.   - Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly-
  - Mr. Fadden moved, That the House do now adjourn.

## EXCISE TARIFF AMENDMENT (No. 6).

That the Schedule to the *Excise Tariff* 1921–1939, as proposed to be amended by the Excise Tariff Proposals introduced into the House of Representatives on the fifth day of March, One thousand nine hundred and forty-two, be further amended as hereinafter set out, and that on and after the twenty-sixth day of March, One thousand nine hundred and forty-two, at nine o'clock in the forenoon, reckoned according to summer time in the Australian Capital Territory, Duties of Excise be collected in pursuance of the *Excise Tariff* 1921–1939 as so amended.
