Mr. Chifley then, by command of His Excellency the Governor-General, laid upon the Table the following

Ordered—That the second reading be made an Order of the Day for the next sitting.

6. Income Tax (War-time Arrangements) Bill 1942.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-Debate resumed.

Mr. Menzies moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for the next sitting.

7. Message from the Senate.—Widows' Pensions Bill 1942.—Mr. Speaker announced the receipt of the following Message from the Senate:-

The Senate returns to the House of Representatives the Bill for "An Act to provide for the Payment of Widows' Pensions, and for other purposes", and requests the House to amend the Bill as set out in Schedule A annexed.
