- 3. RETURN OF THE NINTH DIVISION, A.I.F.-MINISTERIAL STATEMENT.-Mr. Curtin (Prime Minister), by leave, made a Ministerial Statement announcing the arrival in Australia of the Ninth Division of the Australian Imperial Force from service in the Middle East, and extended to the officer commanding, Lieutenant-General Sir Leslie Morshead, and the officers and men a warm welcome

Governor-General.

Message No. 101.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to grant and apply out of the Consolidated Revenue Fund a sum for Invalid and Old-age Pensions.

Mr. Marwick moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

10. Commonwealth Employees' Furlough Bill 1943.—Mr. Lazzarini (Minister assisting the Treasurer), pursuant to leave given on the 10th March, brought up a Bill intituled "A Bill for an Act to make provision for the granting of long-service leave to Commonwealth Employees", and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Lazzarini moved, by leave, That the Bill be now read a second time. Sir Frederick Stewart moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

11. WAR-TIME (COMPANY) TAX ASSESSMENT BILL 1943.—Mr. Lazzarini (Minister assisting the Treasurer), pursuant to leave given on the 10th March, brought up a Bill intituled "A Bill for an Act to amend the 'War-time (Company) Tax Assessment Act 1940-1942'", and moved, That it be now read a

Question—put and passed.—Bill read a first time.

Mr. Lazzarini moved, by leave, That the Bill be now read a second time.

Debate ensued.

Question—put and passed.—Bill read a second time.

Mr. Martens left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole, and agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Prowse reported accordingly.

On the motion of Mr. Lazzarini, the House adopted the Report, and, by leave, the Bill was read a third time.

12. Invalid and Old-age Pensions Bill 1943.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clauses 1 to 3 agreed to.

Clause 4-

Mr. Blackburn moved, as an amendment, That the following be added to the clause:—
"and (d) by omitting from sub-section (2.) the words or if the degree of his capacity for work does not exceed Fifteen per centum' and inserting in their stead the words 'in any remunerative occupation in which he can reasonably be expected to obtain regular employment'".

Debate ensued.

Amendment withdrawn, by leave.

Clause agreed to.

Clause 5 debated and agreed to.

Clause 6 debated-

On the motion of Mr. Holloway (Minister for Social Services), the following amendment was made. after debate :-

Page 3, after proposed new section 23r add the following new section:

"23G. For the purposes of this Part, 'invalid pensioner' includes an Interpretation. old-age pensioner who is permanently incapacitated for work.".

Clause, as amended, agreed to.

Clause 7 debated and agreed to.

Clauses 8 to 13 agreed to.

Clause 14-

Mr. Blackburn moved, as an amendment, That the following be added to the clause:—" and (b) by

adding the following proviso:

Provided that the Minister may direct that an amount, not exceeding the amount of the suspended pension, may be applied, on such conditions and for such period as the Minister directs, towards the cost of maintenance of the pensioner while he is an inmate of an asylum for the insane.'. Amendment negatived.

Clause agreed to.

Clauses 15 to 17 agreed to.

Clause 18 debated and agreed to.

Clause 19 agreed to.

Title agreed to.

Bill to be reported with an amendment.

The House resumed; Mr. Prowse reported accordingly. On the motion of Mr. Holloway, by leave, the House adopted the Report, and, by leave, the Bill was read a third time.

13. ADJOURNMENT.—Mr. Chifley (Treasurer) moved, That the House do now adjourn.

Debate ensued.

Question—put and passed.
