### FRIDAY, 26TH MARCH, 1943.

- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable W. M. Nairn) took the Chair, and read Prayers.
- 2. PRICE CONTROL OF PRIMARY PRODUCTS—MINISTERIAL STATEMENT.—Mr. Beasley (Minister representing the Minister for Trade and Customs), by leave, made a Ministerial Statement surveying the operations of price control on leading primary products.
- 3. ALLEGED MISUSE OF OFFICIAL MOTOR CARS-STATEMENT.-Mr. Beasley (Minister for Supply and Shipping), by leave, made a Statement with reference to the withdrawal made and the apology submitted by the newspaper which had alleged the misuse by him of official motor cars.
- 4. COMMONWEALTH PUBLIC SERVICE BILL 1943.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—Debate resumed.
  - Mr. Menzies moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof :---"the Bill be withdrawn and redrafted so as to provide for preference to former members of the Forces in the Service of the Commonwealth, of all authorities set up under Commonwealth law and of all contractors with the Commonwealth.".

Mr. Rosevear was granted leave to continue his speech when the debate is resumed.

Ordered-That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for the next sitting.

5. MESSAGE FROM THE SENATE.—AUSTRALIAN SOLDIERS' REPATRIATION BILL 1943.—Mr. Speaker announced the receipt of the following Message from the Senate :---
