- 3. MISUSE OF MANPOWER AND MATERIALS-STATEMENT BY MEMBER.-Mr. Morgan, by leave, made a Statement in which he complained of delay in making departmental inquiries into allegations by him regarding the misuse of manpower and materials in the construction of certain buildings at
 - Mr. Dedman (Minister for War Organization of Industry), by leave, also made a Statement in connexion with the matter.
- 4. Papers.—The following Papers were presented, pursuant to Statute—
 - Lands Acquisition Act and National Security (Supplementary) Regulations—Order—Land acquired for Commonwealth purposes—Hobart, Tasmania.

 - National Security Act—National Security (General) Regulations—Order—Use of land.
 Seat of Government Acceptance Act and Seat of Government (Administration) Act—Regulations—1944—No. 2 (Canberra University College Ordinance).
- 5. Supply ["Grievance Day"].—Pursuant to the provisions of Standing Order No. 241, the Order of the Day having been read for going into the Committee of Supply—

Question proposed—That Mr. Speaker do now leave the Chair.

Mr. Chifley (Treasurer) moved, That the debate be now adjourned.
