- 3. Broadcasting Committee-Fifth Report.-Mr. Guy brought up the Fifth Report from the Parliamentary Standing Committee on Broadcasting, and moved, That the Paper be printed. Question—put and passed.
- 4. 10. Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Riordan reported accordingly.

Resolved—That the House will, at the next sitting, again resolve itself into the said Committee.

- 12. ADJOURNMENT.-Mr. Forde (Minister for the Army) moved, That the House do now adjourn. Question—put and passed.
- And then the House, at ten minutes to twelve o'clock midnight, adjourned until to-morrow at half-past ten o'clock a.m.
