FRIDAY, 1st DECEMBER, 1944.

- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. DEATH OF MR. G. A. FRANCIS. Mr. Forde (Acting Prime Minister) informed the House of the death, on the 30th November, of Mr. G. A. Francis, and moved, That this House expresses its sincere regret at the death of Mr. Grosvenor Arundell Francis, a former Member of the House of Representatives for the Division of Kennedy, places on record its appreciation of his meritorious public service and tenders its deep sympathy to his widow and the members of his family in their bereavement.
 - And Mr. Menzies (Leader of the Opposition) having seconded the motion, and other honorable members having addressed the House in support thereof, and all Members present having risen, in silence—Question—passed.
- 3. PRIVILEGE—CIRCULATION OF DOCUMENTS.—Mr. Anthony raised a question of Privilege that documents circulated by the Government during a debate became the property of Members, and moved, That the Keast-Hey report circulated during the debate on the Aluminium Industry Bill is now a public document, and, therefore, should be made freely available to all Members. Debate ensued.

Question—put and negatived.

- 4. PROPOSED MOTION OF PRIVILEGE.—Mr. Cameron sought to raise a question of Privilege with reference to the distribution of copies of the Jensen report on the wool industry. Speaker's Ruling.—Mr. Speaker ruled that a motion of Privilege could not be moved at this stage as the matter was not one suddenly arising.
- 5. SURPLUS AIR CREWS—AIR TRAINING CORPS—MINISTERIAL STATEMENT.—Mr. Lazzarini (Acting Minister for Air), by leave, made a Ministerial Statement with reference to surplus air crew personnel in the Royal Australian Air Force and to the future activities of the Air Training Corps.
- 6. ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION.—Mr. Cameron rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely," The action of the Government in supplying to Members of the Parliamentary Labour Party copies of the Jensen report on the wool industry and the Government's refusal to supply copies to Opposition Members and the unfairness of this action and its effects on the wool industry ".

Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly—
Mr. Cameron moved, That the House do now adjourn.
Debate ensued.
Question—put and negatived.
