- 1. The House met, at three o'clock p.m., pursuant to adjournment.-Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. DEATH OF GENERAL SIR HARRY CHAUVEL.—Mr. Chifley (Treasurer) referred to the death on the 4th March of General Sir Harry Chauvel, and moved, That this House expresses its deep regret at the death of General Sir Harry Chauvel, G.C.M.G., K.C.B., places on record its appreciation of his meritorious public service and tenders its profound sympathy to his widow and family in their bereavement.
  - And Mr. Menzies (Leader of the Opposition) having seconded the motion, and Mr. Fadden having addressed the House in support thereof, and all Members present having risen, in silence-Question-passed.
- 3. TRAINING OF EX-SERVICEMEN-MINISTERIAL STATEMENT.-Mr. Dedman (Minister for Post-war Reconstruction), by leave, made a Ministerial Statement with reference to the vocational training of ex-servicemen.

Ordered—That Mr. Lemmon be granted an extension of time. Ordered—That Mr. Riordan be granted an extension of time.

Ordered--That Mr. Cameron be granted an extension of time.

Ordered-That Mr. Langtry be granted an extension of time.

Debate continued.

Mr. Sheehan moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed. Ordered—That the resumption of the debate be made an Order of the Day for the next sitting. F.611.

- 6. ADJOURNMENT.—Mr. Chifley (Treasurer) moved, That the House do now adjourn. Debate ensued.
  Ordered—That Mr. McEwen be granted an extension of time. Debate continued.
  Question—put and passed.
