- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. QUESTIONS WITHOUT NOTICE—STATEMENT BY MEMBER.—Mr. Menzies (Leader of the Opposition), by leave, made a Statement with reference to the arrangements proposed by the Prime Minister in relation to Questions asked without notice.
- 3. MINISTERIAL DUTIES .- Mr. Curtin (Prime Minister) informed the House that, during the absence of Mr. Forde (Minister for the Army) and Mr. Evatt (Attorney-General and Minister for External Affairs) at the San Francisco Conference on World Organization, Senator Fraser would act as Minister for the Army, Mr. Beasley would act as Attorney-General, and that he would act as Minister for External Affairs. Mr. Curtin said that Mr. Dedman would represent the Acting Minister for the Army in the House of Representatives.
- 4. ALTERATION OF DAY OF NEXT MEETING.-Mr. Curtin (Prime Minister) moved, That the House, at its rising, adjourn until Wednesday next at three o'clock p.m. Question—put and passed.
- 5. Postponement of Business.—Ordered—That the intervening business be postponed until after Notices of Motion Nos. 1 and 2, General Business.
- 6. REGULATION-MOTION FOR DISALLOWANCE.-Mr. Adermann moved, pursuant to notice, That Regulation 6B of the National Security (Allied Works) Regulations, made by Statutory Rules 1944, No. 161, be disallowed. Debate ensued.

Motion withdrawn, by leave.

- 7. Presentation of Address in Reply.—Mr. Speaker informed the House that the Address in Reply would be presented to His Royal Highness the Governor-General at Government House at half-past eleven o'clock a.m. on Wednesday next. Mr. Speaker said he would be glad if the mover and seconder, together with other honorable Members,
 - would accompany him to present the Address.
- 8. ADJOURNMENT.—Mr. Curtin (Prime Minister) moved, That the House do now adjourn. Debate ensued. Question—put and passed.
- And then the House, at two minutes past four o'clock p.m., adjourned until Wednesday next at three o'clock p.m.
