TUESDAY, 31st JULY, 1945.

- 1. The House met, at three o'clock p.m., pursuant to adjournment. -Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. ALTERATION OF HOUR OF NEXT MEETING. -- Mr. Chifley (Prime Minister) moved, That the House, at its rising, adjourn until to-morrow at half-past ten o'clock a.m. Question—put and passed.
- 3. Leave of Absence to Member.—Mr. Chifley (Prime Minister) moved, by leave, That leave of absence for two months be given to the honorable Member for Gwydir (Mr. Scully), on the ground of ill-health.

 Question—put and passed.
- 4. Absence of Mr. Scully—Performance of Ministerial Duties.—Mr. Chifley (Prime Minister) informed the House that, during the absence of Mr. Scully, Mr. Forde would act as Minister for Commerce and Agriculture.
- 5. Messages from the Senate. -Mr. Speaker announced the receipt of the following Messages from the Senate:—

[Papua-New Guinea Provisional Administration Bill 1945]--

Mr. SPEAKER,

Message No. 21.

The Senate returns to the House of Representatives the Bill for "An Act to provide for the provisional administration of the Territory of Papua and that portion of the Territory of New Guinea no longer in enemy occupation", and acquaints the House that the Senate has agreed to the Bill without amendment.

7. Special Annuity Bill 1945.—Mr. Chifley (Prime Minister) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to provide for the payment of an Annuity to the Widow of the late the Right Honourable John Curtin.

Question--put and passed.

Mr. Chifley then brought up the Bill accordingly, and moved, That it be now read a first time. Question—put and passed.—Bill read a first time.

Mr. Chifley moved, by leave, That the Bill be now read a second time.

Debate ensued.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clause 1-

Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Riordan reported accordingly.

Resolved-That the House will, at a later hour this day, again resolve itself into the said Committee.

8. Message from the Governor-General .-- Special Annuity Bill 1945.—The following Message from His Royal Highness the Governor-General was presented, and was read by Mr. Speaker:-HENRY.

Governor-General.

Message No. 18.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to provide for the payment of an Annuity to the Widow of the late the Right Honourable John Curtin.

Canberra, 31st July, 1945.

Ordered-That the foregoing Message be taken into consideration, in Committee of the whole House, forthwith.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Mr. Chiffey (Prime Minister) moved, That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to provide for the payment of an Annuity to the Widow of the late the Right Honourable John Curtin.

Question -- put and passed.

Resolution to be reported.

The House resumed; Mr. Riordan reported accordingly.

The said Resolution was read, and, on the motion of Mr. Chifley, by leave, was adopted by the House.

9. Special Annuity Bill 1945.—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House-

Mr. Speaker left the Chair, and the House again resolved itself into a Committee of the Whole.

(In the Committee.)

Clause 1 agreed to.

Remainder of Bill, by leave, taken as a whole, and agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Riordan reported accordingly.

On the motion of Mr. Chifley, the House adopted the Report, and, by leave, the Bill was read a third time.

10. Australian National Airlines Bill 1945.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-

Debate resumed.

Mr. White moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof:—"the Bill be withdrawn and redrafted to provide that the operation of the airlines be left to the existing management and that the amount proposed to be expended in compensation or purchase be allocated to the building of modern airport facilities in the principal cities".

Debate continued.

31st July, 1945.

The House resumed; Mr. Riordan reported accordingly.

On the motion of Mr. Dedman (Minister for Post-war Reconstruction), the House adopted the Report, and, by leave, the Bill was read a third time.

11. ADJOURNMENT.—Mr. Dedman (Minister for Post-war Reconstruction) moved, That the House do now adjourn. Question—put and passed.
