12. Life Insurance Bill 1945.—Senate's Amendments.—The Order of the Day having been read for the consideration in Committee of the whole House of the Amendments made by the Senate in this Bill

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

The Committee proceeded to consider the Amendments, which are as follows:-

SCHEDULE OF THE AMENDMENTS MADE BY THE SENATE.

No. 1.—Page 5, clause 4, after definition of "trade union" add the following definition:—
"'war service' means service with any Naval, Military or Air Forces of any part of the King's

dominions and includes any engagement in aviation as part of that service.".

No. 2.—Page 6, clause 5, line 16, leave out "This", insert "Subject to the next succeeding subsection, this".

No. 3.—Page 6, clause 5, at end of clause add the following sub-clauses:—

"(2.) Where the policies issued by any authority of a State carrying on life insurance business are guaranteed by the State, Division 2 of Part III. of this Act shall not apply to that authority.

(3.) The provisions of this Act shall not apply to-

(a) any fund which is maintained by a company in respect of any part of its life insurance business, where none of the liabilities arising out of that part of its business relates to any policy registered by the company in Australia; or

(b) the part of the life insurance business in respect of which that fund is maintained.".

No. 4.—Page 14, clause 38, line 33, after "liabilities" insert "or expenses".

No. 5.—Page 14, clause 38, line 35, after "liabilities" insert "or expenses".

No. 6.—Page 18, clause 47, at end of clause add the following sub-clauses:-

"(4.) An appeal shall lie to the Court or the Supreme Court of a State or Territory against any refusal of the Commissioner to approve of any person performing the functions of an auditor under this Division, or against any revocation of an approval given in respect of any person under this section.

"(5.) On any such appeal, the Court may confirm or disallow the refusal or revocation.".

No. 7.—Page 21, clause 50, line 8, leave out "the surplus derived from participating policies", insert

"that part of the surplus which is derived from participating policies registered by the company in Australia".

No. 8.—Page 32, clause 79, line 34, after "actuary" insert "or the Commissioner".

No. 9.—Page 32, clause 79, lines 35 to 37, leave out all words after "rebate" (line 35), insert "at a rate greater than-

(a) the maximum rate of commission or rebate to which the first-mentioned actuary had regard when approving the rate of premium; or

(b) the maximum rate of commission or rebate payable by the company, immediately prior to the commencement of this Act, in respect of policies of that class (if any) issued at the rate of premium so approved,

whichever is the greater"

No. 10.—Page 40, clause 103, at end of clause add the following sub-clause:—

"(3.) All persons to whom any such moneys are paid shall apply those moneys in due course of administration and, if the company thinks fit, it may require those persons to give sufficient security by bond or otherwise that the moneys so paid will be so applied.".

No. 11.—Page 42, clause 109, lines 16 to 23, leave out sub-clause (2.). No. 12.—Page 47, clause 120, leave out the clause, insert the following clause:

"120. A policy shall not be avoided merely on the ground that the person whose life is insured died by his own hand or act, sane or insane, or suffered capital punishment, if, upon the true construction of the policy, the company has thereby agreed to pay the sum insured in the events that have happened.".

No. 13.—Page 51, clause 134, at end of clause add the following sub-clause:—

"(3.) The Commissioner shall not be an officer of the Commonwealth Government Insurance Office.".

No. 14.—Page 51, clause 137, leave out the clause, insert the following clause:—
"137.—(1.) Subject to this section, the Commonwealth Government Insurance Office shall not be liable to pay taxes imposed by or under any law of the Commonwealth or of any State or Territory, but that Office shall pay to the Treasurer such sums as are determined by the Treasurer to be equivalent to the amount of the taxes which it would be liable to pay if it were a company.

"(2.) The Commonwealth Government Insurance Office shall be liable to pay such stamp duties imposed by or under any law of the Commonwealth or of any State or Territory as it would be liable to pay if it were a company.

(3.) The Commonwealth Government Insurance Office shall be liable to make such contributions as it would be liable, if it were a company, to make under any law of any State or Territory relating to fire brigades.".

No. 15.—Page 52, clause 141, line 29, after "under" insert "sub-section (2.) of ".
No. 16.—Page 71, Fourth Schedule, after "tables" (first occurring) in paragraph (1.), insert "or to such other tables as are prescribed

No. 17.—Page 71, Fourth Schedule, leave out "A24-29", insert "A1924-29".

No. 18.—Page 73, Sixth Schedule, after "annum" in sub-paragraph (a) of paragraph 2 of Part II., insert "or at such other rate as is prescribed".
