- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. PUBLIC WORKS COMMITTEE-REPORT.-Mr. James (Chairman) brought up the following Report from the Parliamentary Standing Committee on Public Works :-

Report, together with Minutes of Evidence, relating to the proposed Extensions to the School of Public Health and Tropical Medicine, Sydney.

- 3. PETROL AND TYRE SUPPLIES—MINISTERIAL STATEMENT.—Mr. Beasley (Minister representing the Minister for Supply and Shipping), by leave, made a Ministerial Statement with reference to additional supplies of petrol and tyres.

Mr. Beasley moved, by leave, That the Bill be now read a second time.

Mr. Holt moved, That the debate be now adjourned.
